



# Privacy policy of Siteco GmbH

## for the use of the Siteco iQ App

This privacy policy describes how your personal data as a user of the **Siteco iQ app of Siteco GmbH** is processed. It explains how **Siteco GmbH** uses your personal data, what measures are taken to protect your data and what rights you have in relation to your personal data.

### Introduction

The protection of personal data is an important concern for **Siteco GmbH**. Therefore, **Siteco GmbH** processes your personal data in accordance with the regulations of the European Data Protection Regulation (GDPR) and the other applicable legal provisions for the protection of personal data and data security.

### 1. purpose of the processing, categories of data and legal basis of the processing

**Siteco GmbH** processes your personal data exclusively to ensure a secure login for you as a user of the Siteco iQ app. The data are used as follows:

- Login to the Siteco iQ App functions
- Storage of user data in the Google Cloud
- Registration and identification of luminaires via QR-Code

For the above-mentioned purposes, **Siteco GmbH** processes personal data that you yourself have provided or that accrue in connection with your business relationship with us. These are the following categories of data:

- First name and surname of the user
- Telephone number
- E-mail address
- Name or designation of the company
- Address of the company

**Siteco GmbH** processes your personal data on the basis of the regulations listed below:

- for the purpose of carrying out business processes (Article 6 (1) (b) GDPR),
- in order to safeguard the legitimate interests of **Siteco GmbH**, taking into account the interests of the data subjects that are worthy of protection (Article 6 (1) (f) GDPR).

### 2. transmission and dissemination of personal data

When registering the **Siteco iQ app**, **Siteco GmbH** transmits its login data to EU servers of the Google Cloud. Regulations of Google Inc. then also apply here. (<https://support.google.com/cloud/answer/6329727?hl=de>)

### 3. storage periods

Unless an explicit storage period is specified at the time of collection, your personal data will be deleted when it is no longer required to fulfil the purpose for which it was stored and no statutory retention obligations (e.g. commercial, tax or pension law retention obligations) make longer storage necessary.



#### 4. revocability of declarations of consent given

No consent is required for the storage of Siteco iQ data at **Siteco GmbH**, as you have entered this data yourself during registration.

#### 5. your rights

If you have registered for the Siteco iQ app with **Siteco GmbH**, you are entitled to the following rights:

- obtain information about personal data processed about you,
- request the correction of inaccurate personal data,
- request the erasure of the personal data processed,
- request the restriction of the processing of personal data,
- request the transfer of the data; or
- object to the processing of personal data.
